### Qualified Entrant and Entry

- A qualified Entrant (“Entrant”) is 19 years of age or older and has earned a ballot (“entry”) by complying with the “**Contest Details for Tables Golden Bonus**” and “**How to Earn Entries into the Draws for Tables Golden Bonus**” sections below.
- The following persons are not eligible to participate in the contest and, thus, cannot be Entrants:
  - Employees of Casino Nanaimo and its subsidiaries and affiliates (collectively, “Casino Nanaimo”), and the British Columbia Lottery Corporation (“BCLC”), as well as family and household members of same who reside at the same address;

- Two (2) draws will take place every Thursday at 7:00PM & 9:00PM.
- A total of **twenty-six (26)** draws will take place.
- Entries can be earned Sunday through Thursday throughout the promotional period.

### How to Earn Entries into the Draws for Tables Golden Bonus

There are **two ways** to enter the **draws**: Earning Entry through Slot or with a “Self-Addressed-Stamped Envelope” alternative.

- 1. Earning Entry through Table Game Play**
  - Entrant(s) can earn one (1) entry by the following requirements: \$200 buy-in or more with active play on any Table Game, excluding poker at Casino Nanaimo Sunday through Thursday during the promotional period.
  - Entrant(s) can earn a maximum of ten (10) entries per day during the promotional period.
  - Available only to all carded players (Encore Rewards member) who play at Casino Nanaimo.

- No purchase necessary. Anyone may request one (1) Entry in writing by delivering a self- **Casino Nanaimo Guest Services, 620 Terminal Ave, Nanaimo, BC V9R 5E2** addressed, stamped envelope (which must be received during the Contest Period) to **"Tables Golden Bonus"** c/o . The Entry must include their full name, Date of Birth, phone number, and Encore Rewards number. The entrants are responsible to ensure that entries arrive on time; as set out below, Casino Nanaimo is not responsible for any lost, misdirected, or incomplete entries.
- Entries by the SASE Entry are limited to one (1) Entry per Entrant for the Contest Period.

### Draw Procedure for Tables Golden Bonus

Two (2) registered Casino Nanaimo gaming employees will conduct draws:

- There will be two (2) winners every Thursday, one (1) at 7:00PM and one (1) at 9:00PM that will each receive \$500 in table bonus play.
- One (1) entrant will be drawn at 7:00PM and another one (1) entrant will be drawn at 9:00PM on Thursday.
- If there is no confirmed winner, there will be a total of three (3) redraws. After three (3) redraws, the prize will be carried forward to the following draw.
  - For example, if there is no confirmed winner at the 7:00PM draw, the \$500 in bonus play would carry over to the 9:00PM draw, resulting in a prize of \$1,000 in bonus play to be awarded to one (1) entrant.
  - If there is no confirmed winner at the 9:00PM draw, the prize will be carried over to the following Thursday draw at 7:00PM where one (1) entrant will win the bonus play.
- Once the player meets the criteria, security will perform security checks on the Entrant for eligibility verification.
- The player must present their Encore Rewards card at the time of the draw. If the player is not a current member of the Encore Rewards program, there will be a redraw.
- The Winner will fill out the Prize Redemption Form and receive their \$500 in bonus table play loaded onto their Encore Rewards card.
- The prize is non-transferable and there are no substitutions.
- The prize is table bonus play.

### Prize Claiming Conditions for Tables Golden Bonus

- To become a Winner, a Contestant will be required to:
  - Present valid government issued or other valid official identification reasonably establishing the identity of the holder in the sole discretion of Casino Nanaimo, such as a driver's license, passport, or citizenship card.

  - Complete a BCLC Winner's Release form and/or Casino Nanaimo's Winner's Release form before prize is released.
