## Qualified Entrant and Entry

## How to Earn Entries into the draws for 1K Cash Giveaway Random Seat Draws – Progressive Promotion

There are **two ways** to enter the **draws**: Earning Entry through Slot Play, or with a “Self-Addressed-Stamped Envelope” alternative.

### 1. Earning Entry through Slot Play

- Players qualify for the draw by being seated at a slot machine on the gaming floor at the time of the draw.
- Entrant(s) must be playing an active slot machine at participating sites within one (1) minute of the draw time to qualify for the Random Seat Draw.
- Entrant(s) do not need to be an Encore Rewards Member to qualify.

### 2. “Self-Addressed Stamped Envelope” Entry (“SASE Entry”)

- No purchase necessary. Anyone may request one (1) Entry in writing by delivering a self-addressed, stamped envelope (which must be received during the Contest Period) to “**1K Cash Giveaway Random Seat Draws – Progressive Promotion**” c/o **Casino Nanaimo**. The Entry must include their full name, Date of Birth, phone number, and Encore Rewards number. The entrants are responsible to ensure that entries arrive on time; as set out below, CASINO NANAIMO is not responsible for any lost, misdirected, or incomplete entries.
- Entries by the SASE Entry are limited to one (1) Entry per Entrant for the Contest Period.

## Draw Procedure for the 1K Cash Giveaway Random Seat Draws – Progressive Promotion

Two (2) registered CASINO NANAIMO gaming employees will conduct draws:

- Entrant(s) must spin the slot machine at least one (1) minute before the draw time.
- One (1) entrant will be selected at random through Elite Bonusing Suite (EBS).
- Once a qualified player is selected, the Gaming Manager will announce on the PA system that a winner has been selected and that they remain in their seat until the player can be verified.
  - If the winner is present, the winner will produce ID to the Gaming Manager.
  - If the draw winner is not present, there will be a redraw.
    - Unlimited redraws will occur until a winner is present.
  - Gaming Manager will perform security checks on the drawn contestant for eligibility verification.
  - Once IDs are verified through iTrak, the winner will sign a Winner Release Form.
- Upon the verifying the winning player, the Gaming Manager will present the envelopes to the winner.
- Only selected prizes will be awarded manually.
- Prizes will be awarded in cash.
- A winner does not need to be an Encore Rewards Member to receive a prize.
- Must be present to win.

## Prize Claiming Conditions for 1K Cash Giveaway Random Seat Draws – Progressive Promotion

- To become a Winner, a Contestant must:
  - be nineteen (19) years old or older on the date on which the prize is granted.
  - Present valid government issued photo ID establishing the identity of the holder in the sole discretion of CASINO NANAIMO, such as a driver’s license, passport, or citizenship card.
- **An entrant can win a maximum of two (2) draws per day.**
- Only the prizes that have not been selected remain hidden.
- Draws will be conducted by the Gaming Manager through EBS and the winning slot machine will be selected at random.
- Prizes must be accepted as awarded, no substitutions, exchanges, refunds, or transfers.
- Prizes will be awarded in the form of Cash during the contest period.

- Gaming day is from 7:00am PT to 6:59am PT.
