Qualified Entrant and Entry

- A qualified Entrant (“Entrant”) is 19 years of age or older and has earned a ballot (“entry”) by complying with the “**Contest Details for Double Your Jackpot**” and “**How to Earn Entries into the Draws for Double Your Jackpot**” sections below.
- The following persons are not eligible to participate in the contest and, thus, cannot be Entrants:
 - Employees of Casino Nanaimo and its subsidiaries and affiliates (collectively, “Casino Nanaimo”), and the British Columbia Lottery Corporation (“BCLC”), as well as family and household members of same who reside at the same address;
 - Participants of GAMEBREAK (VSE), Casino Nanaimo site barred and BCLC provincial barred persons; and Residence of Quebec.
- Entrants and Entries must meet and adhere to all contest rules as outlined herein. Entrants and/or Entry who do not meet such rules will be disqualified and any potential prize will be forfeited.
- A qualified contestant (“Contestant”) is any entrant who has been selected based on the “**Draw Procedure for the Double Your Jackpot**” section embedded within.
- A qualified winner (“Winner”) is a contestant who wins a prize by complying with the “**Prize Claiming Conditions for Double Your Jackpot**” and “**General Conditions**” set out below.
- Casino Nanaimo reserves the right in its sole discretion to determine whether any person is qualified to be an Entrant or disqualified to be an Entrant, and to disqualify any persons who, in the sole discretion of Casino Nanaimo, act inappropriately at Casino Nanaimo facilities or in connection with the contest, including but not limited to persons who interfere with, tamper with, or inappropriately affect the business of Casino Nanaimo or the administration of the contest.

Contest Details for Double Your Jackpot

- The Contest Period runs from **10:00AM PT Monday, August 31, to 5:00PM PT Sunday, December 27, 2026**.
- Draws will take place every Sunday at 2:00PM & 5:00PM.
- Entries can be earned daily throughout the promotional period.
- Note entries can also be earned directly following the final draw of the previous Double Your Jackpot on August 30, 2026 at 5:00PM.

Prizing for Double Your Jackpot

- There will be a total of **two (2) draws each week** where the prize will be **up to \$2,000 in bonus play**.

How to Earn Entries into the Draws for Double Your Jackpot

There are **two ways** to enter the **draws**: Earning Entry through Slot or with a “Self-Addressed-Stamped Envelope” alternative.

1. Earning Entry through Slot Play

- One (1) Double Your Jackpot entry can be earned by winning a slot hand pay jackpot at any slot machines at Casino Nanaimo during the promotional period.
- A Casino Nanaimo gaming employee will issue the hand pay jackpot winner with a ballot entry.
- Casino Nanaimo gaming employee must fill in the entry clearly with Entrant’s First Name, Last Name, Encore Rewards Number, Date and Time of Jackpot, ASL won at, and the amount and the gaming employees authorization number before issuing to the entrant.
- There is no limit to how many entries can be earned during the promotional period.

- Entries can be earned on any slot machine at Casino Nanaimo.
- To be eligible, must be an Encore Rewards Member.

2. "Self-Addressed Stamped Envelope" Entry ("SASE Entry")

- No purchase necessary. Anyone may request one (1) Entry in writing by delivering a self-addressed, stamped envelope (which must be received during the Contest Period) to **"Double Your Jackpot" c/o Casino Nanaimo Guest Services, 620 Terminal Ave, Nanaimo, BC V9R 5E2**. The Entry must include their full name, Date of Birth, phone number, and Encore Rewards number. The entrants are responsible to ensure that entries arrive on time; as set out below, Casino Nanaimo is not responsible for any lost, misdirected, or incomplete entries.
- Entries by the SASE Entry are limited to one (1) Entry per Entrant for the Contest Period.

Procedure and Prize Claiming

- Entrants who win a hand pay jackpot daily during the promotional period will receive a completed Double Your Jackpot entry and be informed by an Casino Nanaimo gaming employee to return it on a future Sunday during the promotional period.
- The jackpot winner must present an Encore Rewards card to be eligible to participate.
- Entrants can only earn an entry from a hand pay jackpot and the information on the entry must be completely filled out and recorded by the Casino Nanaimo gaming employee.
- The draw barrel will be brought out by Guest Services on Sunday mornings.
- Entrants can deposit their Double Your Jackpot entries on any Sunday during the promotional period.
- Once an entry has been deposited into the draw barrel, it will be applied to the upcoming draw on Sunday at 2PM.

Draw Procedure for Double Your Jackpot

Two (2) registered Casino Nanaimo gaming employees will conduct the draws:

- One (1) Entrant will be selected at random through the entries that were entered to the draw.
- Once the player is selected, the Drawn Entrants' name will be announced via PA system multiple times and entrant is required to identify themselves within two (2) minutes of the first announcement.
 - If no entrant is present for the draw, three (3) redraws will occur until a winner is found. Within each of the three (3) redraws, one (1) unique name will be drawn.
 - At the 2PM draw, if no unique name is drawn after three (3) draws, the prize will be carried over to the following 5PM draw time for two (2) players to win Double Your Jackpot.
 - At the 5PM draw, unlimited redraws will occur until a winner is found.
 - Example: If the 2PM draw is unclaimed then the following 5PM draw there will be two (2) unique players that will have their jackpot doubled.
 - **If only one winner is present after three (3) redraws, the second prize will be forfeit.**
- Security will perform security checks on the Entrant for eligibility verification.
- **Once a winner has been identified, two (2) registered Casino Nanaimo gaming employees will read the jackpot amount on the reverse side of the entry and provide the winner with the equivalent amount of bonus play, up to \$2,000.**
- Upon verification of security check, the player will fill out the Prize Redemption Form.
- Bonus Play prizes will be loaded on the players' card within thirty (30) minutes of completion of the draws.

Prize Claiming Conditions for Double Your Jackpot

- To become a Winner, a Contestant must:
 - be nineteen (19) years old or older on the date on which the prize is granted.
 - Present valid government issued photo ID establishing the identity of the holder in the sole discretion of Casino Nanaimo, such as a driver's license, passport, or citizenship card.
 - Correctly answer without mechanical or external assistance a mathematical skill-testing question to be administered by the draw coordinator, and
 - Complete a BCLC Winner's Release form and/or the Winner's Release form before prize is released.
- **An Entrant can win a maximum of one (1) time per week.**
- Earned entries must be deposited into the correct / assigned draw barrel prior to the start of the draw.

- Earned entries must be deposited at the same participating site as where it was received. The site's logo is shown on the back of the entry.
- **An eligible entry will include the Entrant's First Name, Last Name, Encore Rewards Number, Date and Time of Jackpot, ASL won at and amount, and the gaming employees' authorization. If any of these fields are missing, the entry is disqualified.**
- Entries that are drawn, that are not eligible (i.e., incomplete) will not be entered back into the draw barrel.
- Entries that are drawn will not be entered back into the draw barrel after each draw.
- **Entries will be emptied from the draw barrel at the end of the 5:00PM draw each Sunday. The draw box is removed from the gaming floor and returned the following Sunday morning.**
- Entrant(s) must be present to win.
- Prizes must be accepted as awarded, no substitutions, exchanges, refunds, or transfers.
- Entries are non-transferable.
- The draw location and draw barrel will be at Guest Services.
- Promotion can be postponed or cancelled without notice.
- Odds of winning depend on number of eligible entries received.

- Gaming day is from 7:00am PT to 6:59am PT.
