Qualified Entrant and Entry

- A qualified Entrant ("Entrant") is 19 years of age or older and has earned a ballot ("entry") by complying with the **"Contest Details for Shake, Rattle, Roll & Twist"** and **"How to Earn Entries into the Draws for Shake, Rattle, Roll & Twist"** sections below.
- The following persons are not eligible to participate in the contest and, thus, cannot be Entrants:
 - Employees of Casino Nanaimo and its subsidiaries and affiliates (collectively, "Casino Nanaimo"), and the British Columbia Lottery Corporation ("BCLC"), as well as family and household members of same who reside at the same address;
 - Participants of GAMEBREAK (VSE), Casino Nanaimo site barred and BCLC provincial barred persons; and Residence of Quebec.
- Entrants and Entries must meet and adhere to all contest rules as outlined herein. Entrants and/or Entry who do not meet such rules will be disqualified and any potential prize will be forfeited.
- A qualified contestant ("Contestant") is any entrant who has been selected based on the **"Draw Procedure for the Shake, Rattle, Roll & Twist"** section embedded within.
- A qualified winner ("Winner") is a contestant who wins a prize by complying with the **"Prize Claiming Conditions for Shake, Rattle, Roll & Twist"** and **"General Conditions"** set out below.

Contest Details for Shake, Rattle, Roll & Twist

- The Contest Period runs from **10:00AM Sunday, September 6 to 11:00PM PT Friday, December 25, 2026**.
- Draws will take place on Friday & Saturday at 8:00PM & 11:00PM, starting on Friday, September 11, 2026.
- There will be a total of **sixty-two (62)** draws. Plus, a New Years Eve draw for \$2027 in chips.
- Guests actively playing on any table games, excluding electronic table games (ETGs) or Poker, will be eligible to win.
- One winner per draw time.
- The participating site will be Casino Nanaimo.

- \$1,000 Cash prize will be awarded in the form of cash.

How to Earn Entries into the draws for Shake, Rattle, Roll & Twist

There are two ways to enter the draws: earning an entry through the main table games (excluding ETGs & Poker) or with a "Self-Addressed-Stamped Envelope" alternative.

1. **Earning an Entry through main table games** (excluding ETGs & Poker)
 - All active players playing table games at 8:00PM or 11:00PM on Fridays & Saturdays will be eligible to win.
 - All eligible table seat numbers will be printed out, laminated and placed in an opaque bag to draw from to determine a Random Table Seat Draw winner.
 - Only one winner per Random Table Seat Draw, for a total of 62 draws throughout the duration of the promotion.
 - Must be present to win.

2. Self-Addressed Stamped Envelope" Entry ("SASE Entry")

- No purchase necessary. Anyone may request one (1) Entry in writing by delivering a self-addressed, stamped envelope (which must be received during the Contest Period) to "Shake Rattle, Roll & Twist", c/o Casino Nanaimo Guest Services, 620 Terminal Ave, Nanaimo, BC V9R 5E2. The Entry must include their full name, Date of Birth, phone number, and Encore Rewards number. The entrants are responsible to ensure that entries arrive on time; as set out below, Casino Nanaimo is not responsible for any lost, misdirected or incomplete entries.

Prizing and Draw Procedure for Shake, Rattle, Roll & Twist

- Random Table Seat draws will occur at the time of the draws.
- Once a winner has been confirmed, to determine the prize amount, the winner shakes the Pai Gow dice shaker which contains two dice.
- The lowest of the two dice is cancelled off and the guests receive the higher amount in Table Games Bonus Play or Cash.
- The value of the pips on the dice is as follows:
 - 2 = \$200 in Table Game Bonus Play
 - 3 = \$300 in Table Game Bonus Play
 - 4 = \$400 in Table Game Bonus Play
 - 5 = \$500 in Table Game Bonus Play
 - 6 = \$600 in Table Game Bonus Play
- If two of the same number is rolled, the guest must re-roll (except for two 1's).
- A re-roll will also take place if the dice are not definitively showing the pips (tiled on the edge of the shaker, etc.).
- If two double 1's are rolled, the guest wins \$1,000 in cash.
- All doubles are re-rolls except for double ones.
- **Additionally, all 62 weekly winners will receive a ballot to complete and place in the designated New Year's Eve draw barrel. One (1) winner will be drawn on Thursday, December 31, 2026, at 8:00PM for a chance to win \$2,027 in table games chips. Must be present to win. If the drawn winner does not claim the prize within two (2) minutes, consecutive redraws will take place until a verified winner is present.**

Prize Claiming Conditions for Shake, Rattle, Roll & Twist

- To become a Winner, a Contestant must:
 - be nineteen (19) years old or older on the date on which the prize is granted.
 - Present valid government issued photo ID establishing the identity of the holder in the sole discretion of Casino Nanaimo, such as a driver's license, passport, or citizenship card.
 - Correctly answer without mechanical or external assistance a mathematical skill-testing question to be administered by the draw coordinator, and
 - Complete a BCLC Winner's Release form and/or the Winner's Release form before prize is released.
- Entrant(s) must be present to win.

- The drawing location will be at the table games area at Casino Nanaimo.
